Leslie, first I hope your husband is doing well and you are under less stress. I appreciate that this is a difficult time for you. However, since I did not hear from you in response to the proposal that was conveyed yesterday and to protect my client's interests, I have filed an amended answer containing a counterclaim for a temporary restraining order and injunctive relief in 08 CV 4924. The temporary restraining order is only to prohibit the destruction of the records. I have asked that the TRO be issued ex parte pending a hearing. The amended answer and counterclaim is attached with the exhibits and the certification. I will dismiss the other action for injunctive relief. I provided the court with your response in the other action. Of course if the proposal is accepted, there will be no need to go to court on the motion.
